Minutes.

A1. The Minutes of the Meeting of 8th May 2019 (Part A and Part B) having previously been circulated, were taken as read and were confirmed.

and VE Day

A2. The Council noted that the U.K. and Guernsey had decided to move the early May Bank Holiday in 2020 from Monday 4th May to Friday 8th May, in order to commemorate the 75th Anniversary of Victory in Europe (VE) Day.

As the 75th Anniversary of the Liberation of the Channel Islands fell on the following day, the Council considered that this offered the possibility for an additional public holiday in 2020, given the importance of the 75th Anniversary of VE Day. The Council therefore decided that Friday 8th May should, subject to the agreement of the States Assembly, be designated as a public holiday (in addition to Monday 4th May and Saturday 9th May, which would both remain public holidays) in order to mark this significant milestone in the Island's history.

The Council accordingly agreed that an appropriate proposition should be lodged 'au Greffe' for consideration by the States Assembly, at the earliest opportunity, and directed officers to take the necessary action.
