Minutes. A1. The Minutes of the meetings of 4th and 18th July 2018 (both Part A and Part B) having previously been circulated, were taken as read and were confirmed.

Matters Arising. A2. The Council, with reference to its Minute No. B7 of 4th July 2018 agreed, at the request of Deputy J.H. Young of St. Brelade, to amend the wording of the paragraph beginning '*The Treasurer of the States advised...*' to insert the word 'significantly' before the word 'above'.

The Council, with reference to its Minute No. B1 of 18th July 2018, noted that the Children's Service Improvement Board would be chaired jointly by the Chief Minister and the Minister for Children and Housing.
