

Health Certificate to export dogs and cats to Third Countries

Application for an official export certificate for dogs and cats to a Third Country outside the EU

Most Third Countries require a pet animal to have a health certificate to enter. It is the owners/exporters responsibility to adhere to any requirements laid down by country you are importing to, although the department will endeavour to help you wherever possible. You will need to ensure that you find out from the authorities of the country you are travelling to, if they will accept a health certificate issued in Jersey, which is part of the British Isles and has the same import requirements as the United Kingdom for rabies.

If the importing country requires an import licence, please include a copy, together with any associated guidance, when submitting this application.

Applications for export certificates can be submitted to the Environment up to two months prior to export. We cannot guarantee the issue of an export certificate where 20 days' notice have not been given.



20. **Animal transporter**, tell us who you are using to help you with the transport arrangements such as customs import permits, quarantine, if required, and to transport your pet to the point of departure in the UK if going by road (not the airline or ferry).

Guidance notes

- You should use this form where countries require a Ministry/Government export certificate
- It is the responsibility of the exporter or their agent to ensure that an import permit/licence (if applicable) has been applied for from the authorities of the country to which the animal is to be exported
- The department is not able to issue an export certificate for some countries, check with the department, in some cases the export certificate may have to be obtained from the authorities in the United Kingdom
- The submission of this application form should not be delayed if precise details of the proposed date of export or premises of origin etc. are not known. Full details must however be provided immediately when the information is available to enable the us to issue the necessary export health certificate in time
- We may have to contact you for additional information as the requirements for some countries may vary. It is important that we can contact you quickly. A mobile number and an email address, if you have them, are helpful
- The export certificate will be forwarded direct by us to the nominated veterinary officer on the application form. The veterinary surgeon must be authorised to complete the health certificate and will be responsible for completing the health certificate and vaccination details at the time of pre-export examination. If the health certificate is in two parts both parts will have to be completed in Jersey
- The veterinary surgeon who provides services to the exporter or their agent in connection with the export health certification, will require payment for such services
- Import regulations for countries to which or through which animals are to be exported can be obtained from the department, at the above address, however you are advised to contact the import country as well
- You must use a separate form for animals going to different countries or where they are being sent separately to the same destination
- You must ensure that the correct documentation accompanies the animals; otherwise they may be returned to the United Kingdom. It is an offence under the Animal Health Act 1981 to land an animal in the United Kingdom without an import licence. Where exported animals are not accompanied by the correct certificates and are returned to United Kingdom without an import licence, they may be detained, re-exported or destroyed at your expense
- Welfare during transport legislation places a duty on the person in charge of the animals during transit to ensure that their welfare is protected
- The airline or shipping company who have agreed to carry your animal(s) will advise you on crating, feeding, watering and general care of your animal(s) during transit
- Only one copy of the export health certificate will be issued to accompany the animals. If further copies are required the final certificate may be photocopied by the exporter or their agent who should ask the veterinary officer to stamp and countersign the copy
- The type or brand of microchip to be used may not be specified. Where an animal is required to be fitted with a microchip for identification. ISO (International Standards Organisation) Standard microchips

meeting specifications 11784 or Annex A of ISO Standard 11785 are generally used. ISO Standards are used in Europe

- If the microchip does not meet these ISO Standards, it may be the importer's responsibility to ensure that the microchip can be read upon entry to a country. This may mean that the importer will need to provide a microchip reader (at their expense) to enable the chip to be read. Some ports of entry may have microchip readers capable of reading other types of microchip and this should be checked with the authorities before travel.
