The Inspector assessed the proposals with reference to the first two of these SPGs, which were in draft form at the time of his report, but did not address the third SPG which triggers the provisions of Policy H6 – Making homes more affordable, but only once the SPG is adopted. The SPG is now adopted and, therefore, gives effect to Policy H6 which requires at least 15% of new homes on development schemes of 50 homes or more to be available for assisted purchase. The SPG is now a material consideration in the determination of planning applications. Article 19(1) of the Planning and Building (Jersey) Law, 2002 requires that all material considerations be taken into account in the determination of an application for planning permission.

As planning application reference P/2022/0388 was not considered against Policy H6, the Assistant Minister has referred the appeal back to the Inspector for a detailed assessment to be made of the application against the requirement of Policy H6 as a material consideration.

The Inspector has been requested to prepare a supplementary report for the Assistant Minister's consideration who will determine the appeal once the report has been duly considered. As the appeal is now back in the hands of the Inspector, the Assistant Minister is unable to offer an estimate as to when the final determination will be made.

Attached are the relevant Ministerial Decision documents relating to the referral back to the Inspector.
