DECLARATION OF SPECIAL MEASURES: FOOT AND MOUTH DISEASE IMPORTATION OF UNTREATED WOOL AND HAIR OF SUSCEPTIBLE ANIMALS FROM CERTAIN THIRD COUNTRIES AND TERRITORIES

# Animal Health (Jersey) Law 2016

Animal Health (Importation of Miscellaneous Goods and Animals) (Jersey) Order 2017

EU Legislation (Veterinary and Zootechnical Checks – Trade with Member States) (Jersey) Regulations 2016

The Minister for the Environment

- a. Has reasonable grounds for suspecting the existence of Foot and Mouth disease in certain third countries and territories, such that certain animals and animal products originating from territories subject to special transitional import arrangements are liable to pose a risk to animal health.
- b. In exercise of the powers conferred under Regulation 15 of the EU Legislation (Veterinary and Zootechnical Checks – Trade with Member States) (Jersey) Regulations 2016 the Minister for the Environment declares the following special measures to be necessary in Jersey to contain the risk to animal health:
  - Suspension of entry into Jersey of the following animal by-products from susceptible animals originating from relevant countries and territories:

1.1 untreated wool; and

1.2 untreated hair

2. If the untreated wool or hair referred to in paragraph 1 originates from an FMD free zone listed in Annex 2 to this Declaration, they must be accompanied by a completed health certificate using the model provided in Annex 3 to this Declaration.

# 3. Interpretation

In this Declaration:

a) "relevant countries and territories" means all countries and territories
except the countries and territories listed in Annex 1 to this Declaration, or
FMD-free zones listed in Annex 2 to this Declaration;

b) "untreated wool" and "untreated hair" have the same meanings as in Annex I to Commission Regulation (EU) No 142/2011 implementing Regulation (EC) No 1069/2009 of the European Parliament and of the Council laying down health rules as regards animal by-products and derived products not intended for human consumption and implementing Council Directive 97/78/EC as regards certain samples and items exempt from veterinary checks at the border under that Directive; and

c) "susceptible animals" means a cow, bull, sheep, goat, deer, camel, llama, alpaca, guanaco, vicuna, any other ruminant, elephant or rodents
