The work of Public Health and Strategic Health Policy will be covered in the Health Care Jersey departmental Business Plan.

Key Objectives

The Cabinet Office enables Ministers and public servants to deliver better services and improve the lives of Islanders. During 2025 and the first quarter of 2026, we will do this by:

Curbing the growth of the public service

Deliver the Budget (Government Plan) 2025 savings targets from the Cabinet Office's Head of Expenditure, specifically £1.681M savings during 2025 and £1.335M savings during 2026. We will achieve this by right-sizing the Cabinet Office using the following levers:

- Maintaining an external recruitment freeze on all non-essential roles and those above Grade 11;
- Avoiding spend on external consultancy unless it is for essential technical services;
- Prioritising the department's asks of Digital Services, to ensure that all activities will improve the benefits for islanders and provide value for money;
- Continue to prioritise talent development for on-island staff and apply the principles of diversity, equity and inclusion.

Policy: Advising and supporting Ministers

Advise and support Ministers to deliver the Common Strategic Policy and other public policy during 2025 and the first quarter of 2026.

Where this will require legislation, the Government's Legislative Programme is listed in Annex A. New public policy development is listed in Annex B.

From those lists, the most significant policy development activity in 2025 and the first quarter of 2026 includes:

- Delivery of legislation on Residential Tenancy (CSP commitment);
- Delivery of legislation to implement the recommendations of the Violence Against Women and Girls' (VAWG) Taskforce (CSP commitment);
- Improve parents' access to affordable quality childcare (CSP commitment);
- Changes to the Planning and Building Law as part wider reform of planning services (CSP commitment); and
- Delivering legislation on the consent regime for the development of Offshore Wind in Jersey waters. Develop and evidence the strategic options for an offshore windfarm for a debate by the States Assembly before the next election (States Assembly commitment).

Statistics and Analytics

The Chief Statistician is a statutory office holder and the new Statistics and Census (Jersey) Amendment Law embeds the independence of the profession into law. Statistics Jersey and analytic teams across the Government will continue to produce high quality information that informs policy development and contributes to the debates within the public sector, the States Assembly, businesses and the community. The planned statistical outputs are published in advance to aid planning and transparency – they are <u>available here</u>. In particular, the plans include:

- Retail Prices Index on a quarterly basis;
- Public Sector Staffing Statistics on a quarterly basis;
- Business Tendency Survey reintroduced from Q2 2025 following an Amendment to the Budget 2025-28;
- Measuring Jersey's economy in GVA and GDP for 2024
- Population and migration statistics for 2024;
- Jersey Opinion and Lifestyle Survey December 2025 (provisional date);
- Better Life Index March 2026.

Ministerial Support

The team promote good political governance, collaborating with other officials while also offering constructive challenge in support effective decision-making and to deliver on the objectives of Ministers (and for this reason, operates with autonomy within the Cabinet Office). The Ministerial Office provides a wide range of day-to-day support and administrative services to Ministers, including meeting management and correspondence, and aids in the discharge of Ministers' duties to the States Assembly.

In 2025, the team will focus on efficiency improvements via increased levels of automation in workflows while supporting Ministers and Departments in the final delivery of the Common Strategic Policy, as well as other work programmes such as the legislative programme.

Information Governance

The central Information Governance function supports Departments with their obligations under the Freedom of Information, Data Protection, and Public Records legislation, including FOI and Subject Access Requests, and Data Protection Impact Assessments.

In 2025, the team will focus on improving the speed, efficiency, and consistency of processing, including due diligence arrangements and expanded policy and procedural advice. They will also contribute to the review of the Freedom of Information Law commissioned by the Chief Minister.

Communications

Following the 2024 restructure to a smaller team, the Communications Service has a new vision and purpose: to champion an open, authentic and accessible government whilst guarding against misinformation, disinformation, and reputational harm. New ways of working are being implemented, including a rigorous control process for campaign spend across departments, outsourcing of design and marketing activity to the local creative sector, enhanced reporting on the effectiveness of communications, and a focus on planned CSP communications throughout 2025.

Customer feedback

Improve internal customer satisfaction scores, measured through the use of surveys and reported quarterly, working towards the overall Government of Jersey target of 80% by year end. Cabinet Office internal customers are primarily public servants making use of support on policy, legislation, Ministerial support or communications.

Freedom of Information

Report biannually on responses to Freedom of Information (FOI) requests submitted to the Government of Jersey within the statutory timeframe. The target is to respond to at least 95 per cent of requests within the timeframe given by the FOI legislation of 20 working days, or within an agreed extension of up to 65 working days.

The percentage is in line with the UK Information Commissioner's Office FOI toolkit which assesses 90 per cent of responses processed within the statutory timeframe as "adequate" and over 95 per cent as "good".

Publication of statistics reports

Release all Statistics Jersey 2025 and 2026 publications according to the publication release schedule on gov.je with a target of 100 per cent.

Value for money

Deliver the Budget (Government Plan) 2025 savings targets from the Cabinet Office's Head of Expenditure, specifically £1.681M savings during 2025 and £1.335M savings during 2026.
