Minutes.	A1. The Minutes of the meetings of 24th September and 8th and 16th October 2024 (Parts A and B), having previously been circulated, were taken as read and were confirmed, subject to some minor amendments to the Part A Minutes of 24th September 2024.
Declarations of interest.	A2. No declarations of interest were received in connexion with any of the items discussed at the current meeting.
Forthcoming business.	A3. The Council discussed the following items of public business, which were scheduled to be debated by the States Assembly at the meeting on 12th November -
	<u>Make States old age pensions exempt from tax</u> (in-Committee debate) It was noted that, as this online petition had exceeded 5,000 signatures, it would be the subject of an in-Committee debate, following the agreement of the States Assembly on 11th September 2024.
	The Council welcomed Mr. R. Summersgill, Comptroller of Taxes, Treasury and Exchequer, to the meeting and was reminded that the Minister for Treasury and Resources had presented a report on the petition (R.164/2024 referred), which <i>inter alia</i> clarified that approximately 50 per cent of all pensioners in Jersey did not currently pay income tax, as their income was below the exemption threshold, which was £20,000 for a single person and £32,050 for married couples or those in a civil partnership (plus the second earner's threshold of £7,950, where applicable).
	As the ageing demographic increased, the cost of providing the States old age pension would augment. It was estimated that the amount of income tax paid on the old age pension by those pensioners, whose income exceeded the aforementioned threshold, was currently between £22 and 23 million <i>per annum</i> . Any reduction in revenue would require funding through the Social Security Fund, which would, as a consequence, deprive future pensioners; and
	Draft Royal Court and Stamp Duties and Fees (Jersey) Amendment Law 202- (P.67/2024) The Council was informed that one of the provisions of this draft Law, which had
	been lodged by the Minister for Treasury and Resources, would enable the Minister,

after consultation with the Bailiff, the Viscount and the Judicial Greffier, to amend certain judicial fees by Ministerial Order. It was noted that Deputy Sir P.M. Bailhache of St. Clement had lodged an Amendment to the draft Law to the effect that any such uprate should be made by Regulations, rather than by Order.

The Council was informed that the Minister would aim to lodge her own Amendment to the draft Law to provide that only increases in line with (or below) the Retail Price Index could be made by Order, with greater uplifts requiring approval by the States Assembly by virtue of Regulations.
