Declarations of interest.

A1. No declarations of interest were received in connexion with any items considered at the current meeting.

Forthcoming business.

A2. The Council discussed the following items of public business, which were scheduled to be debated by the States Assembly at the meetings on 21st May and 11th June 2024 –

Common Strategic Policy 2024-2026 (P.21/2024)

It was noted that 4 amendments had been lodged to this proposition and the Council discussed those in respect of which it intended to lodge its own amendments. Ministers were reminded of both the deadline for the same and that these would require associated children's rights impact assessments;

Assisted Dying (P.18/2024)

Ministers gave consideration to the amendment, which had been lodged by the Assisted Dying Review Panel and decided that it was prepared to accept it; and

Jersey Consumer Council: Re-appointment of Chairman (P.23/2024)

The Council was informed that the constitution of the Jersey Consumer Council (JCC) had been amended (R.61/2024 referred) to extend the maximum tenure of the Chair (and JCC members) up to 9 years from the current 6 consecutive years. This was noted to align with the guidance issued by the Jersey Appointments Commission in respect of the recruitment of senior States employees and appointees and members of independent bodies. It was noted that the current Chair of the JCC had been in post for 6 years and, as his tenure had involved the fallow period of the COVID-19 pandemic, the additional 3 years would afford him the opportunity to bring his plans for the JCC to fruition.
