Minutes.

Forthcoming business.

A3. The Council discussed the following items of public business, which were scheduled to be debated by the States Assembly at the meeting on 1st October 2024.

Delivery of 3 bilingual primary schools (P.45/2024)

The Council recalled that the above proposition had been lodged 'au Greffe' by Deputy Sir P.M. Bailhache of St. Clement. Deputy R.J. Ward of St. Helier Central, Minister for Education and Lifelong Learning, had presented comments on the proposition on 4th September 2024 which indicated that he was unable to support the same. He added that a survey on the proposition had been circulated to Headteachers and that the resulting feedback had been published on 16th September 2024.

The published feedback was overwhelmingly against the proposition. All 21 Headteachers who had responded to the survey had objected to establishing 3 bilingual primary schools. Ministers were reminded that there was nothing to prevent any individual Headteacher, who wished to progress such a proposal from presenting a business case to the Minister for Education and Lifelong Learning.

Nationality Acts: Extension to Jersey (P.55 / 2024)

The Council recalled that the above proposition had been lodged by the Chief Minister and that the States Assembly would be asked to consent to the extension of various provisions concerning British citizenship. These were contained in the Acts and subordinate legislation of the Parliament of the United Kingdom, as set out in the appendices to the proposition. The Council concluded that it was minded to support the proposition, which was due for debate on 1st October 2024.
