Declarations of interest.

- A1. Declarations of interest were received from the following Ministers in respect of items discussed at the current meeting –
- Deputy I.J. Gorst of St. Mary, St. Ouen and St. Peter, Minister for External Relations, in connexion with item B4, to the extent that he and his wife were directors of a company which potentially employed one individual who was not currently paid the living wage; and
- Deputy R.J. Ward of St. Helier Central, Minister for Education and Lifelong Learning in connexion with the discussion of forthcoming business ('Fully funding education or training for all 16-18 year olds (P.38/2024)), to the extent that his wife was employed at Highlands College.

Forthcoming business.

A2. The Council discussed the following items of public business, which were scheduled to be debated by the States Assembly at the meetings on 25th June and 16th July 2024 –

Strategic Reserve Fund: Long-term funding plan (P.22/2024)

The Council recalled that it had presented comments on the proposition of Deputy M.B. Andrews of St. Helier North and noted that the proposer had since lodged an amendment to his proposition. This notwithstanding, the Council decided to continue to oppose the same;

Draft Statistics and Census (Jersey) Amendment Law 202- (P.29/2024)

It was noted that Deputy Sir P.M. Bailhache of St. Clement had lodged an amendment to P.29/2024 and the Council was informed that the intention was for it to lodge an amendment thereto, with which Deputy Bailhache was in agreement.

Officers informed Ministers that the Privileges and Procedures Committee (PPC) was minded to also amend the proposition and, accordingly, it was agreed that it would be prudent to defer consideration until the meeting of the States Assembly of 16th July 2024, to afford sufficient time for any amendment from PPC to be considered; and

<u>Cannabis:</u> <u>Decriminalisation of personal possession and recreational use</u> (P.31/2024)

The Council recalled that it had lodged the second amendment to the proposition of Deputy T.A. Coles of St. Helier South, which amended paragraph (b) and removed paragraph (c) thereof. Deputy Coles had subsequently amended his own proposition to remove reference to people over the age of 18, which was an anomaly that the Council had discussed at its meeting on 4th June 2024.

It was noted that Deputy I. Gardiner of St. Helier North had lodged an amendment requesting that the Minister for Health and Social Services should reclassify cannabinol and cannabinol derivatives from Class A to Class B controlled drugs after consultation with the Misue of Drugs Advisory Council. Ministers were of the view that this predetermined the outcome of any such consultation and were, accordingly, supportive of the Minister lodging an amendment to Deputy Gardiner's amendment which referenced the Minister considering the reclassification of such drugs.
