Minutes.	A1. The Minutes of the meeting of 14th November 2024 (Part A only), having previously been circulated, were taken as read and were confirmed.

	Connétable M.K. Jackson of St. Brelade declared an interest in relation to item No. B3 of the current meeting, as the Chair of a body that was regulated by the Jersey Care Commission. He and Deputy Luce also declared an item in relation to item No. B1 in connexion with the lifeboats.
Forthcoming business.	A3. The Council discussed the following items of forthcoming business, which were scheduled to be discussed at the meeting on 10th December $2024 -$
	Reporting on Ministerial Affairs (P.71/2024) It was recalled that this Proposition, which had been lodged by Deputy K.L. Moore of St. Mary, St. Ouen and St. Peter, requested the Chief Minister to update the Ministerial Code before 31st December 2024 to (a) publish monthly details of all external meetings attended by Ministers and Assistant Ministers and (b) details of their off-Island travel, including the attendant costs.
	The Council was mindful that details of Ministers' off-Island travel was already provided on an annual basis. Having discussed at length the advantages and disadvantages of introducing a requirement to publish monthly details of attendance at external meetings in a small jurisdiction, it was confirmed that comments should

be prepared, which outlined the challenges represented by the proposal and undertaking to revert to the Assembly within a period of 6 months;

### Modern Languages in Schools (P.74/2024)

The Council noted the details of an amendment by Deputy R.J. Ward of St. Helier Central, Minister for Education and Lifelong Learning, to the proposition of Deputy M. Tadier of St. Brelade and indicated its support for the same; and

# Support Scheme for individuals qualifying to represent Jersey in off-Island competitions (P.82/2024)

The Council recalled that it had previously given initial consideration to this proposition of Deputy R.S. Kovacs of St. Saviour and was mindful that, whilst the current allocation of £125,000 in subsidies, was frequently oversubscribed, it was of the view that the proposed figure of £500,000 was too great. Accordingly, it considered and signified its support for a proposed amendment by the Minister for Sustainable Economic Development, which inter alia replaced that amount with a sum of £250,000.

Children's The Council, with reference to Minute No. B5 of 25th January 2022 of the A4. Council, as previously constituted, welcomed Dr. C. Corrigan, Children's Commissioner, to the meeting and received and noted a PowerPoint presentation in connexion with her Strategic Plan 2024-27 (the Plan).

> The Commissioner informed the Council that, in April 2024, she had commenced a consultation to inform the Plan, which had involved surveying a range of young people and key stakeholders, visits to 16 schools and requests for input via social media. In excess of 1,000 responses had been received, of which 319 had come from children aged under 13 years, 516 from young people aged between 13 and 17 years and 230 from adults. Recurring themes that had emerged from the consultation included play and leisure, educational inequality and mental health and wellbeing, the latter most notably from amongst the older cohorts.

> The Commissioner had also reviewed existing evidence around those issues which affected children and young people both locally and more widely and had considered national and international priority issues, as raised by the Council of Europe, United Nations and the European Network of Ombudspersons for Europe. It was noted that these aligned with the situation in Jersey.

> The Council was informed that the stated aims of the Office of the Children's Commissioner (OCC) were to -

- work to make as many people as possible aware of the rights of children and young people and provide information and advice about those rights;
- involve children in its work through a variety of means including the Youth Advisory Group:
- ensure that the Government gave appropriate consideration to children's rights when making decisions and enacting laws;
- work to have the rights of children and young people included in Jersey's policies and laws;
- work with and learn from partners in other countries and international organisations to promote the rights of young people; and
- run the office in an open, accessible and responsible way.

During 2025, the Commissioner intended to raise awareness of the OCC through strengthening networks to facilitate collaborative working and having a more visible presence both in the Island and internationally. She aimed to increase knowledge around children's rights across all sectors and would commission a review on

educational inequalities.

The Council noted the position and thanked the Commissioner for attending.
