Revision of the Display Screen Equipment Approved Code of Practice Consultation response report

Executive summary

The existing Display Screen Equipment at Work: Approved Code of Practice came into force on 1 December 1998. Whilst it still reflects the principles of good practice, a revision is overdue to reflect the variety of modern working practices.

Whilst retaining the over-riding principles, in developing the draft ACoP the Health and Safety Inspectorate (HSI) has taken into account authoritative guidance published by the UK HSE and other relevant representative industry bodies.

The HSI launched a formal consultation on 5 January 2024 and invited interested stakeholders to comment on the draft ACoP with a questionnaire provided to help structure the responses. The consultation ran until 23 February 2024.

Nine formal written responses were received representing employers, employees, training providers and health & safety professionals. 8 respondents used the consultation questionnaire and 1 opted to answer the consultation questions with free text.

The results showed unanimous agreement that an updated ACoP was needed given the changes with ways of working and advances in technology.

A recommendation will therefore be made to the Minister for Social Security to formally approve a revised DSE ACoP in accordance with Article 10 of the HSW Law. The final ACoP will broadly reflect the consultation with amendments to reflect the constructive suggestions made by consultees.

Consultation findings

- 1. All respondents were familiar with the existing Display Screen Equipment: Approved Code of Practice 1998.
- 2. All respondents agreed that a revised/updated ACoP identifying standards of good practice and those required to comply with the general duties under Health & Safety at Work (Jersey) Law 1989 would be beneficial.
- 3. Most respondents found the way the new proposed ACoP is structured to make it easy to understand. Suggestions were made for improved sectional layout and more detailed information on what constitutes good practice in order to comply with the Law.
- 4. Most respondents agreed that the new proposed ACoP sufficiently reflected the range of modern working situations. More information on chair selection and examples of hybrid working models was requested.
- 5. The majority of respondents agreed that the proposed new ACoP sufficiently covered the range of devices used. Additional detail was suggested on the use of multiple

- screens and to widen the consideration of what equipment meets the definition of 'modern' DSE equipment. It was also suggested that the minimum workstation requirements would be helpful to retain from the existing ACoP.
- 6. Additional comments were made around the phraseology and terminology of using 'worker' instead of employee as used in Health & Safety (Jersey) Law 1989, expanded review criteria and clarity on basic risk assessment versus DSE assessment. There were also suggestions on changes to wording and sectional layout to aid understanding.

Conclusion

There was overwhelming support from those contributing to the consultation exercise for the proposed revision of the ACoP

Comments were primarily concerned with identifying areas where additional guidance or clarification would be considered helpful

Next steps

The feedback from this consultation will be considered during the development of the final draft ACoP, with the intention of this being formally approved by the Minister for Social Security.
