

## Waste Management (Jersey) Law 2005 (the 'Law')

## **Application to Transfer a Waste Management Licence (Article 34)**

It is a legal requirement under Article 34 of the Law that an application must be made to transfer a waste management licence.

The application must provide sufficient information to enable a decision about the transfer of a licence and the likelihood that environmental problems may occur in the future. The information to be considered includes the state of the land on which the authorised waste activity has been carried out and the measures taken to prevent and remedy environmental problems as a consequence of the waste activities.

Please note a fee is payable to apply to transfer a waste management licence.
