Lead regeneration strategy for government, developing and maintaining a broad range of evidenceinformed policy, legislation, strategy and plans, and providing expert advice to Ministers and Directors General to ensure the Island's social, environmental and economic objectives are met.

The principal officer responsible for the Future Places Ministerial Group and associated projects with significant direct impact on the legal frameworks in force in Jersey, on public service provision across the island, on public finances and spending, and on the reputation of the Government of Jersey.

#### Job specific outcomes

Provide honest, objective and impartial advice to Ministers, the Council of Ministers - and once decisions are taken, publicly support and help deliver them. Provide accurate and professional briefings, advice, guidance and documentation, and prepare Ministers effectively to respond to States Assembly questions, Scrutiny and Public Accounts Committee hearings, stakeholder meetings and the media. These activities will ensure Ministers are effective in progressing their government agenda and in responding to democratic scrutiny.

Act as the principal officer supporting the Future Places Ministerial Group, ensuring the group has a clear forward plan of decisions, is effective in delivering its agreed terms of reference and, in particular, can attend both to near-term and urgent decisions while continuing to progress plans for the medium-to longer-term.

Identify where action is required and work closely with other government departments and Arm's Length Functions including Andium Homes, the Jersey Development Company, Ports of Jersey; and with the construction industry, utilities providers and others.

Deliver evidence-informed policy, legislation and strategic planning to meet Ministerial regeneration objectives, the Government's strategic aims, and Jersey's international obligations; and across policy area(s) and/or priorities.

Deliver structured and engaged policy/strategy/plan development projects, including evidenceinformed analysis and robust public engagement, to ensure the development of future-orientated policy/strategy/plans.



Consider the most effective mode(s) of engagement, including innovative approaches being used elsewhere, in order to involve the public, service users, frontline staff, delivery partners, and/or wider stakeholders in policy and strategy development and evaluation; thereby ensuring outcomes are appropriate, deliverable and informed by stakeholders.

Ensure that the policy, planning and legislative frameworks in your specialist area remain effective and relevant by pro-actively identifying when action is needed. Work closely with partner departments including the Law Officers' Department and Law Draftsmen's Office, so that Jersey policy and law are appropriate, robust and achieve the intended outcomes.

Build strong relationships and networks by representing the Island in inter-jurisdictional activities, leading knowledge transfer and development. Develop strong links across jurisdictions, departments, industry / business and other key stakeholders, including the public and their representatives, affording a network of contacts to inform the work of your team.

Deliver a whole-Island and long term approach to enhance decision-making. Undertake horizon scanning and scenario planning to develop a vision of how Jersey can meet future challenges. Take a fresh look at issues, and consider how Jersey might innovate to respond to them in order to improve both current and longer-term policies, strategies and plans, achieving better outcomes for Islanders.

Improve the effectiveness of government and service performance, by leading the appraisal of corporate plans, policies or projects proposed by other departments and/or external organisations to ensure consistency with strategic objectives, in-so-doing nurturing consistency and quality of policy/strategy/planning across the public sector.

Manage delivery against work plans. Ensure clarity of responsibility with implementation teams, including review and evaluation. This will result in policy and strategy projects which deliver their intended objectives, including improved services and outcomes for Islanders.

Lead, manage and direct staff, to deliver on time and to quality standards. Invest in the personal and career development of staff. Undertake appraisals, management of sickness absence, disciplinary matters, recruitment and selection. Commission and manage consultants and contracts for services. Act as a role model at all times, supporting teams and individuals to develop and achieve their potential and encouraging a learning culture focused upon improvement and high performance.

#### Statutory responsibilities

Active engagement, participation and compliance with any other statutory responsibilities applicable to the role, as amended from time to time.

This role is politically restricted. The jobholder is not permitted to undertake political activity involving standing for election to the States or as a Parish Constable, or publicly supporting someone who is standing for election or playing a public part in any political manner.
