Job purpose

The post holder will work as part of a multidisciplinary team within the Diabetes Centre Team, responsible for providing a highly specialist seamless pathway to delivering and providing a high quality and safe effective podiatric care to patients. Working closely with Consultants, Diabetes Specialist Nurses, Dietitians, Orthotists, other Health Care Professionals and other staff to support the prevention of and management of foot ulceration.

Job specific outcomes

- Undertake triage of referrals and complex assessments of patients with diabetes including those with diverse complex presentations/multiple-pathologies using investigative skills, (by taking complex medical histories; requesting blood samples and X-rays), analytical, clinical reasoning and assessment skills
- Assess and screen patients using the diabetic foot assessment/screening tool, ensuring copies are available to appropriate members of the multi-professional team, such as patient's GP or practice nurse. Provide specialised health care advice and treatment based on results of assessment and risk categorisation.
- Develop and implement comprehensive individualised highly specialist
 programmes of care, and wound management, for patients with chronic
 neuropathy, acute and chronic vascular problems, referring to other
 specialties/services as required using one's knowledge of a range of evidence
 based treatment options and recommend the best course of intervention and to
 develop comprehensive discharge plans
- Provide highly specialist highly skilled treatment of ulcers on the lower limb.
 Debride devitalised tissue and promote wound healing including wound care advice and dressings and highly specialist alternative treatments for foot wounds i.e. VAC therapy, advanced wound care dressing.
- Provide advanced vascular assessment of the lower limb to diagnose circulatory problems by using diagnostic tools – Doppler Ultrasound - to undertake Ankle Brachial Pressure Index (ABPI) and Toe Brachial Pressure Index (TBPI), using




highly specialist knowledge training and skill beyond normal practice of the podiatrist and arrange further consultation by Vascular Consultant as required.

- Provide pressure relief for diabetic feet by prescribing offloading devices such as insoles, application of soft cast, Aircast walkers, and total contact casts. Casting is not currently in use but planned for future service provision. Undertake biomechanical assessment for patients referred by other health care professionals referring to highly specialist service as required in order to consider appropriate offloading techniques and prescribe and adapt orthotic devices to enhance foot function and where necessary referral for appropriate footwear.
- Ensure that control of Vascular Disease risk factors are being addressed and
 inform GP's of any findings. To provide and re-enforce appropriate lifestyle advice
 to the patients /carers including smoking cessation and exercise and direct as
 appropriate. Provide information and advice regarding vascular disease risk
 factors. Liaise with the Diabetes Consultant or GP in the management of
 hypertension, cholesterol, and the provision of appropriate anti platelet medication
- Provide highly developed specialist advice to podiatry colleagues working within other locations regarding the podiatry management of the at risk diabetic foot
- Assessing of patient understanding of treatment proposals, gain valid consent and have the ability to work within a legal framework with patients who lack capacity to consent to treatment
