

Quality Assurance	Data is collected primarily from the Viewpoint crime recording system, which encompasses a number of sub systems, as well as from standalone systems such intelligence, partner agencies and national systems.		
Data Technology	The Police Analysis team use Alteryx, PowerBi, i2, CSAS, SQL, Azure and other tools from the Microsoft suite.		
Data Analysis / Interpretation	The Police analysis team focus on using data and various evidence-based methodologies to identify threat/harm/risk and evaluate demand & performance.		
Subject Matter Expertise	The team members need solid understanding of the business area within which they work (policing, intelligence operations, wider criminal justice and safeguarding), as well as knowledge of analytical methods for producing relevant and quality insights.		
Data Promotion	The team serve as the primary function for the promotion of using and understanding data for decision making, within the organisation and across Government.
