Thank you, [REDACTED], for putting me so clearly in the picture. I had no idea of the scale of the issue. Your email adds to my concerns

Personally, I put GP's as a very high priority since we have adopted the Jersey Care Model without, I believe understanding the full resource and organisational implications. Also, we have transferred tens of millions of pounds in the govt plan from the Health Insurance fund to make this happen. Some of that resource should be made available to the JCC to carry out the tasks you have identified. It needs to be well targeted.

So I am puzzled how we can hope to deliver the JCM without having a clear strategy for GPs practices in the absence of the key information which i would have expected to be available somewhere in the States machine. I hope we have not lost the index key to it. So, i will be taking this up with other ministers.

Dear Minister

I do not have detailed answers to the questions you have posed and I am advised by the Care Commission that they do not hold this information either as it falls outside its jurisdiction. I thought it would be helpful to set out some background information on the regulation of GPs to assist with your enquiries on these matters, and I would be pleased to assist further, if I can.

Regulation of GP Services (i.e. Service Regulation)

The short answer to why the Care Commission does not hold the information you have requested is because GP services (like the hospital and, frankly, most other health and social care and educational settings) are not independently regulated in Jersey.

Under the Regulation of Care project it is intended to regulate GPs and dentists in phase 4. Phase 1 is to regulate social work and mental health services for children which, as you know, [REDACTED] (I will provide a briefing to you on this very soon as I am hoping to seek your approval to lodge draft legislation before the election). Phase 2 is adult social care and mental health services. Phase 3 will be the hospital and clinic services.

This is a programme which was approved in 2018 [REDACTED]. However, clearly it is subject to change, depending on the Government's priorities going forward.

Dear Ministers

I wish to lodge an amendment to P.115 brought by Senator Pallett, in the terms below. I will need to have it ready for tomorrow to send to the Greffe though we can also discuss at COM on Tuesday when Anuschka proposes to make a short presentation to explain the progress and improvements we will be making in rehabilitation services. We will be finalising the report to the amendment tomorrow. However if anyone has any comments at this stage, I would be pleased to receive them.

Original Proposition:

THE STATES are asked to decide whether they are of opinion -

to request the Minister for Health and Social Services to:

(a) to reinstate the full suite of stroke and injury rehabilitation services facilities and beds at the earliest opportunity, but no later than 1st March 2022, either at Samars Ward at Overdale or at another suitable location, as determined by the

Minister; and

(b) ensure that a purpose-built rehabilitation unit offering the full suite of stroke and injury rehabilitation service facilities and beds formerly offered at Samars Ward is delivered as part of the development of a new hospital campus at Overdale, or at another suitable location.

Proposed amendment

THE STATES are asked to decide whether they are of opinion -

to request the Minister for Health and Social Services to:

(a) to review and improve the full suite of stroke and injury rehabilitation services and facilities at the earliest opportunity, but no later than 1st March 2022, on Plémont Ward, across other relevant General Hospital wards as well as community rehabilitation services to ensure patients have a

responsive rehabilitation service experience, services are clinically safe, high quality and focused on patient outcomes; and

(b) ensure that stroke, injury and other rehabilitation services and required facilities are delivered, both in inpatient units and in the community, as part of the development of the new hospital campus at Overdale and the Jersey Care Model programme.
