Further to your response [REDACTED] below I just wanted to update you that I have checked in on progress on the [REDACTED] report and we hope to be in a position to publish it at some point next month. We will keep you updated. As you suggest we can look to arrange a meeting to discuss the report's findings in relation to rugby face-to-face and I will ask officers to arrange this. I understand that other conversations with the government around debt owed are underway.

For clarity and recognising the fact that you have described your current situation as urgent, I do not at this stage expect that report to change the decision previously communicated in respect of a request for funding. That decision, as my letter of response set out, was made for a number of reasons which I would not expect to be impacted by the work within the remit of the [REDACTED] report.
