Further to our communications earlier in the week, and ahead of the start of the Budget 2015 debate Monday, please find attached:

1. Minister for Treasury and Resources' response to Corporate Services Scrutiny Report on the Draft 2015 Budget (SR 12/2014) – an initial response was sent to Members on Monday. This is the full response to the Panel's report.

1. PAC has this morning presented comments on my Amendment 5, which concerns a withdrawal from the Car Park Trading Fund. Here is the Treasury comment, produced with the help of TTS Officers, which we hope Members find useful.

1. A number of further comments have been made around Income forecasts, including further questions. I am taking the unusual step of providing in advance of Monday a copy of a draft written answer in an attempt to draw a line under this continuing line of questioning.

I am indebted to the very considerable efforts of the Interim Treasurer, as well as officials at Treasury, Income Tax, Impôts, Chief Minister's Office, Economics Unit, and Communications Unit, for their work helping prepare these documents for members. I'm also grateful for the support of the ministerial colleagues for their continuing work and support.

If any Member has any questions or queries in relation to any Budget 2015 matters, please, as always, do not hesitate to contact Eddie or myself over the weekend.

NOTE: A joint ministerial response from the Health Minister, Chief Minister and myself concerning the Health and Social Services Scrutiny Panel report is being sent out by email early tomorrow morning. This complies with the request of the Scrutiny Panel. Members will receive a full response to Panel's report as well as the Ministerial Oversight Groups Expert Panel Review and our response.
