Just a few observations as I suspect you will be wanting to get on with this given post the New Year there is only about 12 weeks left on [REDACTED] secondment.

It is good to see the role pitched at a senior level and that it has been split. I felt [REDACTED] was much too stretched in the latter stages of his tenure and this approach should alleviate that quite significantly.

A span breaker for the FSU is a smart move and will create the headroom for the strategic and policy focus needed.
