Dear Mark,

It's been over six weeks now since we met to discuss our pay claim and over 4 weeks since we submitted our revised claim, yet we haven't received any correspondence back from the employer regarding our meeting, our submission or an offer of any sort.

You contacted me last Friday (a week ago today) to state that you would be sending out a letter concerning our claim, but again, I have not received any correspondence. I'm concerned Mark that the employer states verbally that it can't do much until a new SEB is formed, yet has met with several groups to discuss pay already.

The lack of communication Mark and/ or physical evidence of meaningful negotiation worries me and it's starting to feel that the employer is not meeting its objectives as part of our Non Impairment of Service agreement. I'd rather we get together within the next 14 days to discuss a genuine offer than reach a failure to agree so early due to the employer acting unreasonably, especially as our continued involvement in other disputes hinges heavily on the employers ability to run simultaneous negotiations.

As stated Mark, you stated that we would hear back from you when you telephoned me last Friday, I would have presumed that we would be in receipt of this by today.
