#### Introduction

The Jersey Harbour Master, and Ports of Jersey Ltd, request authorisation to implement a maritime exclusion zone following an incident involving a Jersey-registered maritime vessel.

#### Recommendation

Other Approve Ports of Jersey to take the necessary actions

### Detail

Decision(s):

The Minister, having been apprised of the circumstances of a maritime incident having occurred at approximately 0530 hrs Thursday 8th December 2022, issued a Direction in accordance with Regulation 1(2)(a) of the Harbours (Jersey) Regulations 1962 to establish a maritime exclusion zone in Jersey territorial waters located at 49° 13.105'N 002°20.024'W, with the radius of the exclusion zone extending out to 750 metres in all directions from the location described above.

The Minister determined that the following activity should be prohibited within the exclusion zone:

- a) the passage of any vessels, and
- b) diving, fishing, laying of static gear and trawling activity.

The Minister further determined that the exclusion zone should not apply to vessels operating with the prior permission of the Harbour Master and in connection with the investigation of or salvage activity arising from the maritime incident.

The Minister authorised the Harbour Master to issue a further Notice to Mariners to extinguish the above maritime exclusion zone once the Harbour Master was satisfied that any salvage operation required at the site had been completed successfully and / or that there was no longer any material concern of risks to navigation at that location.

#### Reason(s) for Decision:

The wreck constitutes a risk to navigation, a potential hazard to divers and fishermen and is the subject of an investigation being conducted in accordance with Article 166(1) of the Shipping (Jersey) Law 2002.
