## **ECONOMIC DEVELOPMENT (2014 FEES) (AMENDMENT) (JERSEY) ORDER 2013**

*Coming into force*

**THE MINISTER FOR ECONOMIC DEVELOPMENT**, in pursuance of Regulation 7 of the Sea Fisheries (Licensing of Fishing Boats) (Jersey) Regulations 2003, Regulation 3 of the Sea Fisheries (Underwater Fishing) (Jersey) Regulations 2003 and Regulations 2 and 5 of the Sea Fisheries (Fisheries) (Jersey) Regulations 2010, orders as follows –

### **1 Economic Development (2014 Fees) (Jersey) Order 2013 amended**

In the Economic Development (2014 Fees) (Jersey) Order 2013 –

- (a) in the preamble, for the words “and Articles 12 and 38 of the Weights and Measures (Jersey) Law 1967” there are substituted the words “, Articles 12 and 38 of the Weights and Measures (Jersey) Law 1967, Regulation 7 of the Sea Fisheries (Licensing of Fishing Boats) (Jersey) Regulations 2003, Regulation 3 of the Sea Fisheries (Underwater Fishing) (Jersey) Regulations 2003 and Regulations 2 and 5 of the Sea Fisheries (Fisheries) (Jersey) Regulation 2010”;
- (b) after Article 3 there is inserted the following Article –

#### **“3A Sea Fisheries (General Fees) (Jersey) Order 2010 amended**

- (1) In the Sea Fisheries (General Fees) (Jersey) Order 2010 –
  - (a) in Article 1 for the amount ‘£92.00’ there is substituted the amount ‘£94.30’;
  - (b) in Article 2(a) for the amount ‘£80.95’ there is substituted the amount ‘£82.95’;
  - (c) in Article 2(b) for the amount ‘£16.90’ there is substituted the amount ‘£17.30’;
  - (d) in Article 3(1) for the amount ‘£167.50’ there is substituted the amount ‘£171.65’;
  - (e) in Article 3(2)(a)(i) for the amount ‘£167.50’ there is substituted the amount ‘£171.65’;

(f) in Article 3(2)(a)(ii) for the amount ‘£25.40’ there is substituted the amount ‘£26.03’.

(2) Despite Article 4(2), this Article comes into force on 1st January 2014.”.

**2 Citation and commencement**

This Order may be cited as the Economic Development (2014 Fees) (Amendment) (Jersey) Order 2013 and comes into force on 1st January 2014.
