Detail

Following an appeal against the refusal of planning permission, reference P/2023/1023, Sue Bell was appointed as the independent Planning Inspector to consider the appeal and all statements and other plans and documents associated with the appeal.

The Assistant Minister has given full consideration to the appeal papers, Island Plan policies, supplementary planning guidance and to the Inspector's report.
