

ROAD RACING (MOTOR VEHICLE RALLY) (JERSEY) ORDER 2006

THE MINISTER FOR TRANSPORT AND TECHNICAL SERVICES, in pursuance of Article 2 of the Motor Vehicle Races (Jersey) Law 1946¹, and on the application of the Jersey Motor Cycle and Light Car Club, orders as follows –

1 Interpretation

In this Order, "promoters" means the Jersey Motor Cycle and Light Car Club.

2 Use of courses in Schedule for races with motor vehicles

- (1) The promoters may use each of the courses (consisting of public roads and portions of public roads) described in Parts 1 to 8 (inclusive) of the Schedule for races with motor vehicles, on the date and between the hours shown in relation to that course.
- (2) For that purpose, the promoters may close those courses to traffic on the date and between the hours shown in relation to those courses.

3 Application of other enactment

This Order is subject to the Road Racing (General Provisions) (Jersey) $Order 1959^2$.

4 Citation

This Order may be cited as the Road Racing (Motor Vehicle Rally) (Jersey) Order 2006.

SCHEDULE

(Article 2)

PART 1

A course comprising the following public roads, and portions of public roads, in the Parishes of Trinity and Saint John –

La Rue de La Fontaine de Colard, from a point 250 metres east of its junction with La Rue Coutanche to its junction with La Rue Coutanche; thence along La Rue Coutanche and La Rue de La Fontaine to the latter's junction with La Rue de la Ville a L'Eveque; thence along La Rue de la Ville a L'Eveque to its junction with La Rue des Monnieres; thence along La Rue de Brabant to its junction with La Rue de Brabant; thence along La Rue de Brabant to its junction with La Rue des Canons; thence along La Rue des Canons and La Rue du Poivre to the latter's junction with La Rue des Haue des Houguettes; thence along La Rue du Douet; thence along La Rue des Haue du Douet to its junction with La Rue du Becq; thence along La Rue du Becq to its junction with La Rue du Grand Jardin; thence along La Rue du Grand Jardin to its junction with La Rue de La Garenne; thence along La Rue de La Garenne to its junction with La Rue de La Trinite.

Period of closing - Friday 13th October 2006 between 12.30 p.m. and 5.30 p.m.

PART 2

A course comprising the following public roads, and portions of public roads, in the Parish of Trinity –

Le Mont de Rozel from its junction with Le Chemin du Guet to its junction with La Route de Rozel; thence along La Route de Rozel, La Route des Côtes du Nord and La Rue du Pot du Rocquier to the latter's junction with La Rue du Becquet; thence along La Rue du Becquet to its junction with La Rue des Bouillons; thence along La Rue de Sous les Bois to the latter's junction with La Rue de La Falaise; thence along La Rue de La Falaise in a northerly direction to its junction with Le Chemin D'Olivet; thence along Le Chemin D'Olivet to its junction with La Rue du Boulay.

Period of closing – Friday 13th October 2006 between 12.30 p.m. and 5.30 p.m.

PART 3

A course comprising the following public roads, and portions of public roads, in the Parishes of Saint Lawrence and Saint John -

Le Chemin des Moulins from the Millbrook Pumping Station to its junction with Le Mont du Bu de La Rue; thence along Le Mont du Bu de La Rue to its junction with La Route de St Jean; thence along La Route de St Jean to its junction with La Rue des Biliéres; thence along La Rue des Biliéres to its junction with Le Chemin des Moulins; thence along Le Chemin des Moulins to its junction with Le Mont de la Chenaie; thence along Le Mont de la Chenaie to its junction with La Rue des Corvées; thence along La Rue des Corvées, Le Mont au Meunier and La Rue de La Hauteur to the latter's junction with La Fraide Rue and La Rue de Ia Ville ès Gazeaux; thence along La Rue de Ia Ville ès Gazeaux to its junction with Le Mont Gavey and La Rue de Bas; thence along La Rue de Bas to its junction with La Ruette; thence along La Ruette to its junction with La Rue de la Patente; thence along La Rue de la Patente to its junction with Le Chemin des Moulins; thence along Le Chemin des Moulins to its junction with Le Charrieres Nicolle; thence along Le Charrières Nicolle to its junction with La Route de St Jean; thence along La Rue de St Jean to its junction with La Rue des Saints Germains; thence along La Rue des Saints Germains to its junction with La Rue des Servais.

Period of closing – Friday 13th October 2006 between 5.30 p.m. and 10.30 p.m.

PART 4

A course comprising the following public roads, and portions of public roads, in the Parish of Saint Helier –

Mount Bingham from its junction with the eastern arm of South Hill to its junction with the western arm of South Hill; thence along the western arm of South Hill, through its junction with Fort Regent Road, thence along the northern arm of South Hill to its junction with Pier Road; thence along Pier Road to its junction with The Quay.

Period of closing – Friday 13th October 2006 between 6.00 p.m. and 10.15 p.m.

PART 5

A course comprising the following public roads, and portions of public roads, in the Parishes of Saint Mary, Saint Ouen and Saint Peter –

Le Chemin du Cätel from its junction with La Rue de Crabbé to its junction with Le Mont de Ste Marie; thence along Le Mont de Ste Marie to its junction with Le Mont Vibert; thence along Le Mont Vibert to its junction with La Rue de la Ville au Neveu; thence along La Rue de la Ville au Neveu to its junction with La Rue Mahier; thence along La Rue Mahier to its junction with La Rue du Pont; thence along La Rue du Pont to its junction with Le Chemin de L'Eglise; thence along Le Chemin de L'Eglise to its junction with La Preterie; thence along La Preterie to its junction with La Rue de la Botellerie; thence along La Rue du Douet; thence along La Rue du Douet to its junction with La Rue du Douet; thence along La Rue de la Mare des Cauchez; thence along La Rue de la Mare des Cauchez to its junction with La Verte Rue; thence along La Verte Rue to its junction with Le Pont au Bré; thence along Le Pont au Bré to its junction with La Grand Route des Augerez.

Period of closing – Saturday 14th October 2006 between 07.45 a.m. and 1 p.m.

PART 6

A course comprising the following public roads, and portions of public roads, in the Parishes of Saint Ouen and Saint Peter -

La Rue a L'Eau from its junction with La Rue des Nouettes to its junction with La Cache de L'Eglise; thence along La Cache de L'Eglise to its junction with La Rue au Prieur; thence along La Rue au Prieur to its junction with La Rue de la Mare and La Cache ès Frêsnes; thence along La Cache és Frêsnes to its junction with La Rue du Manoir; thence along La Rue du Manoir to its junction with La Ville de L'Eglise; thence along La Ville de L'Eglise and Le Mont Matthieu to the latter's junction with La Rue du Mont Rossignol; thence along Le Mont Rossignol to its junction with La Route du Moulin; thence along La Route du Moulin to its junction with Le Mont de la Mare; thence along Le Mont de la Mare to its junction with La Rue des Fontaines; thence along La Rue de la Campagne to its junction de la Mare;

Period of closing – Saturday 14th October 2006 between 8 a.m. and 1 p.m.

PART 7

A course comprising the following public roads, and portions of public roads, in the Parishes of Saint Peter, Saint Lawrence and Saint Mary –

La Rue du Coin Varin from its junction with La Rue de St Anastase to its junction with La Rue du Panigot; thence along La Rue du Panigot to its junction with La Route de L'Aleval; thence along La Rue du Petit Aleval to its junction with La Rue du Petit Aleval; thence along La Rue du Petit Aleval to its junction with La Rue des Aix; thence along La Rue des Aix, La Rue Bechervaise and La Cheve Rue to the latter's junction with La Rue ès Bouefs; thence along La Rue des Aix punction with La Rue ès Bouefs; thence along La Rue Bechervaise to its junction with La Rue Bechervaise; thence along La Rue Bechervaise to its junction with La Rue de Ia Ville au Bas; thence along La Rue de Ia Ville au Bas to its junction with Le Feugerel; thence along Le Feugerel to its junction with Le Chemin des Montagnes; thence along Le Chemin des Montagnes to its junction with La Rue Rouge Cul; thence along La Rue Rouge Cul to its junction with Les Six Rues.

Period of closing – Saturday 14th October 2006 between 1 p.m. and 5.30 p.m.

PART 8

A course comprising the following public roads, and portions of public roads, in the Parishes of Saint John and Saint Mary –

Les Charrières de Bonne Nuit from its junction with Les Nouvelles Charrières to its junction with La Rue de la Lande; thence along La Rue de la Lande to its junction with La Rue de Fremont; thence along La Rue de Fremont to its junction with La Rue ès Nonnes; thence along La Rue ès Nonnes to its junction with La Rue de Ia Ville Guyon and La Route du Nord; thence along La Route du Nord, La Rue de Sorel and Le Mont de Ia Barcelone to the latter's junction with Le Chemin des Hougues; thence along Le Chemin des Hougues to the Priory Inn Car Park

Period of closing – Saturday 14th October 2006 between 1.15 p.m. and 5.45 p.m.
