JERSEY INTERNATIONAL AIR DISPLAY (JERSEY) ORDER 2012

Made

Coming into force

THE MINISTER FOR TRANSPORT AND TECHNICAL SERVICES, on the application of Jersey International Air Display a.r.l. and after consultation with the Connétables of Saint Helier, Saint Lawrence, Saint Peter and Saint Brellade, in pursuance of Article 2 of the Entertainments on Public Roads (Jersey) Law 1985, orders as follows –

1 Jersey International Air Display

- (1) If Jersey International Air Display a.r.l. (in this Order called “the promoter”) complies with the requirements as to insurance cover and public notice in Articles 2 and 3, it may on Thursday 13th September 2012 use the public roads specified in paragraph (2) for the viewing of the Jersey International Air Display.
- (2) The public roads to which paragraph (1) refers are –
 - (a) People’s Park car park and the car park, in respect of the former Inn on the Park, that is situated south-west of People’s Park car park and is adjacent to La Route de St. Aubin;
 - (b) the parking lay-bys lying first and second on the promenade, when proceeding westward from West Park;
 - (c) Victoria Avenue, between Bel Royal and the Esplanade;
 - (d) Paris Lane;
 - (e) Tyneville Lane;
 - (f) the spur road that leads from Victoria Avenue into La Route de St. Aubin at First Tower;
 - (g) Farley’s Lane;
 - (h) Rue du Galet; and
 - (i) the beach in St. Aubin’s Bay, between the western wall of Elizabeth Marina and La Haule slipway,

which are collectively called “the site” in this Order.

2 Insurance cover

The requirement as to insurance cover to which Article 1 refers is that the promoter shall produce to the Minister for Transport and Technical Services, not later than Friday 7th September 2012, satisfactory evidence that the promoter is covered by insurance in a manner and to the extent required by the Minister against all liability that may be incurred by any of the following –

- (a) the promoter;
- (b) any official, agent, or servant, of the promoter;
- (c) any person taking part in the air display,

in respect of damage to property, or in respect of the death of or bodily injury to any person, resulting from the holding of the Jersey International Air Display or any arrangements made by the promoter in connection with the air display or this Order.

3 Public notice of restrictions

- (1) The requirement as to public notice to which Article 1 refers is that on 2 occasions during the 5 days immediately before Thursday 13th September 2012, the promoter shall publish in the Jersey Gazette a notice of its intention to use each part of the site under Article 4.
- (2) The notice shall specify –
 - (a) the parts of the site that are to be used;
 - (b) the dates on which and the times between which they will be used and the nature of the restrictions that are imposed by Article 4 on their use;
 - (c) the access permitted or restrictions imposed by Articles 5 and 6; and
 - (d) any incidental arrangements that will apply.
- (3) The notice shall also be certified by the Greffier of the States as a notice that is being published in pursuance of this Article.

4 Restrictions on traffic movement within the site

- (1) Between 6 p.m. on Wednesday 12th September 2012 and 10 a.m. on Friday 14th September 2012, the promoter may close to all vehicular traffic and vehicles People's Park car park and the car park, in respect of the former Inn on the Park, that is situated south-west of People's Park car park and is adjacent to La Route de St. Aubin.
- (2) Between 12 noon and 12.30 p.m. on Thursday 13th September 2012, the promoter shall not permit a driver of a vehicle (other than a permitted vehicle) to enter a restricted access road, unless the conditions in paragraph (3) are fulfilled.
- (3) The conditions mentioned in paragraph (2) are that –
 - (a) the driver is entering the road for the purpose of exiting the relevant part of Victoria Avenue or a lay-by; or

-
- (b) the road is a specified entry road or a lay-by (or is entered via a specified entry road) and the driver is entering the road for the purpose of enabling the vehicle to be parked in a lay-by or a designated lane, and, if the road is a designated disabled persons' lay-by, the driver is –
 - (i) conveying a disabled person,
 - (ii) entering the lay-by for the purpose of enabling the vehicle to be parked in that lay-by, and
 - (iii) permitted by a marshal to park in that lay-by.
 - (4) Between 12 noon and 12.30 p.m. on Thursday 13th September 2012, the promoter shall not permit a driver of a vehicle (other than a permitted vehicle) to park the vehicle –
 - (a) in a designated disabled persons' lay-by, unless the driver is –
 - (i) conveying a disabled person, and
 - (ii) permitted by a marshal to park in that lay-by; or
 - (b) on any other part of a restricted access road, other than a designated lane that is not within the Lower West Park Sealed Area.
 - (5) As soon as practicable after 12.30 p.m. on Thursday 13th September 2012, the promoter shall seal off any road entrance to, or exit from, the Lower West Park Sealed Area.
 - (6) Between the time when paragraph (5) is complied with and 5.30 p.m. on Thursday 13th September 2012, the promoter shall keep the Lower West Park Sealed Area sealed off to all traffic except as may be required to enable a driver conveying a disabled person to enter or exit a designated disabled persons' lay-by under paragraph (7) or (9).
 - (7) Between 12.30 p.m. and 2.00 p.m. on Thursday 13th September 2012, the promoter shall not permit a driver of a vehicle (other than a permitted vehicle) to enter a restricted access road unless –
 - (a) the driver is, in accordance with the requirements of a marshal, entering the road so as to be able to exit the relevant part of Victoria Avenue via a specified exit road; or
 - (b) the conditions in paragraph (8) are fulfilled.
 - (8) The conditions mentioned in paragraph (7) are that –
 - (a) the road is a specified entry road or a lay-by (or is entered via a specified entry road) and is not within the Lower West Park Sealed Area or the early closing parking area;
 - (b) the driver is, in accordance with the requirements of a marshal, entering the road for the purpose of enabling the vehicle to be parked in a lay-by or a designated lane, and, if the road is a designated disabled persons' lay-by, the driver is –
 - (i) conveying a disabled person,
 - (ii) entering the lay-by for the purpose of enabling the vehicle to be parked in that lay-by, and
 - (iii) is permitted by a marshal to park in that lay-by.

- (9) Between 12.30 p.m. and 2.00 p.m. on Thursday 13th September 2012, the promoter shall not permit a driver of a vehicle (other than a permitted vehicle) to park the vehicle –
- (a) in a designated disabled persons' lay-by, unless the driver is –
 - (i) conveying a disabled person, and
 - (ii) permitted by a marshal to park in that lay-by;
 - (b) on any other part of a restricted access road, other than a designated lane that is not within the Lower West Park Sealed Area or the early closing parking area; or
 - (c) in a lay-by that is adjacent to the early closing parking area.
- (10) Between 2.00 p.m. and 5.30 p.m. on Thursday 13th September 2012, the promoter shall not permit a driver of a vehicle (other than a permitted vehicle) –
- (a) to enter a restricted access road, unless –
 - (i) the driver is entering the road so as to be able to exit the relevant part of Victoria Avenue via a specified exit road, and
 - (ii) the driver is permitted by a marshal to exit the site;or
 - (b) to park the vehicle on any part of a restricted access road.
- (11) Between 12 noon and 5.30 p.m. on Thursday 13th September 2012, the promoter shall ensure that –
- (a) appropriate measures are in place to ensure the safety of the public while any vehicle is moving on the relevant part of Victoria Avenue or a lay-by that adjoins the relevant part of Victoria Avenue;
 - (b) no vehicle (other than a permitted vehicle) is parked so as to inhibit entry or exit from a lay-by that adjoins the relevant part of Victoria Avenue;
 - (c) no vehicle is permitted to travel on a restricted access road, or a lay-by that adjoins the relevant part of Victoria Avenue, unless the vehicle is travelling at less than 10 m.p.h.;
 - (d) persons are not permitted to ride bicycles along –
 - (i) so much of Victoria Avenue as extends between the point at which that Avenue intersects with the Esplanade and the point at which that Avenue intersects with La Rue du Galet,
 - (ii) any lay-by adjacent to the part of Victoria Avenue referred to in clause (i), or
 - (iii) the cycle path adjacent to the part of Victoria Avenue referred to in clause (i) or a lay-by referred to in clause (ii);
 - (e) no vehicle enters the southbound or westbound lane of so much of La Rue de Haut as extends between the point at which that road intersects with Le Mont Cambrai and the point at which that road intersects with St. Peter's Valley; and

(f) no vehicle that is wider than 6'6" is permitted to enter La Rue de Haut.

(12) In this Article –

“designated disabled persons’ lay-by” means either of the 2 parking lay-bys that lie first and second on the promenade when proceeding westward from West Park;

“designated lane” means the northernmost eastbound lane of the relevant part of Victoria Avenue and the southernmost westbound lane of the relevant part of Victoria Avenue;

“early closing parking area” means so much of the relevant part of Victoria Avenue as extends between the point at which Victoria Avenue intersects with the Esplanade and the point at which Victoria Avenue intersects with the spur road that leads from Victoria Avenue into La Route de St. Aubin at First Tower;

“Lower West Park Sealed Area” means so much of Victoria Avenue as is adjacent to Lower West Park;

“marshal” means a person appointed by the promoter to direct the movement of traffic for the purposes of the Jersey International Air Display;

“permitted vehicle” means a vehicle being used by –

- (a) a member of the Police Force;
- (b) a fire officer;
- (c) a medical practitioner or nurse acting in the course of his or her duties or a medical emergency; or
- (d) a person acting on behalf of the promoter;

“relevant part of Victoria Avenue” means any point along Victoria Avenue between the point at which that Avenue intersects with Bel Royal and the point at which it intersects with the Esplanade;

“restricted access road” means a public road specified in Article 1(2);

“specified entry road” means La Rue du Galet and the First Tower Slip Road;

“specified exit road” means La Rue du Galet, the First Tower Slip Road or Tyneville Lane.

5 Closure of beach

(1) Between –

- (a) 12.30 p.m. and 5.00 p.m. on Wednesday 12th September 2012, and
- (b) 12 noon and 5.30 p.m. on Thursday 13th September 2012,

the promoter shall close the display area to all vehicular traffic, vehicles and members of the public.

(2) Even if the display area has been closed under paragraph (1), the promoter may at its discretion admit vehicular traffic, vehicles and

members of the public to the display area between the same times on the same dates as are mentioned in that paragraph.

- (3) In this Article, the “display area” is the beach in St. Aubin’s Bay between the western wall of Elizabeth Marina and the La Haule slipway.

6 Other access and restrictions

- (1) Notwithstanding Article 4(2) of the Road Traffic (Saint Lawrence) (Jersey) Order 1990 or Part 2 of Schedule 2 to that Order, a vehicle may be driven –
 - (a) into La Route de St. Aubin from La Route de la Haule; or
 - (b) into La Route de la Haule from La Route de St. Aubin,between 12 noon and 5.30 p.m. on Thursday 13th September 2012.
- (2) Notwithstanding any other enactment –
 - (a) between 9 a.m. and 5.30 p.m. on Thursday 13th September 2012, no vehicle shall be parked, remain parked, or wait, on either side of La Route de St. Aubin between West Park and Bel Royal; and
 - (b) between 9 a.m. and 5.30 p.m. on Thursday 13th September 2012, no vehicle shall be parked, remain parked, or wait, on either side of Gloucester Street between The Parade and the Esplanade.
- (3) Between 12 noon and 5.30 p.m. on Thursday 13th September 2012, the promoter may close –
 - (a) La Rue de la Ville Emphire to eastbound traffic;
 - (b) St. Peter’s Valley, between Bel Royal and the junction with La Rue de Haut, to southbound traffic other than buses and large goods vehicles; and
 - (c) the spur road that leads from La Route de St. Aubin to the Esplanade to eastbound traffic.

This Order may be cited as the Jersey International Air Display (Jersey) Order 2012.
