ISLAND GAMES (CYCLE RACE – GROUVILLE AND ST. MARTIN) (JERSEY) ORDER 2015

Made
Coming into force

THE MINISTER FOR TRANSPORT AND TECHNICAL SERVICES, in pursuance of Article 2 of the Entertainments on Public Roads (Jersey) Law 1985, on the application of Jersey Cycling, and after consultation with the Connétables of Grouville and St. Martin orders as follows –

1 Interpretation

In this Order -

"entertainment" means the entertainment in the form of a cycle race in the parishes of Grouville and St. Martin that is part of an event known as the 2015 Island Games;

"specified periods" means the periods on Tuesday 30th June 2015 between 9.00 a.m. and 1.00 p.m. and between 5.30 a.m. to 9.30 p.m;

"promoter" means the promoter referred to in Article 2.

2 Promoter

For the purposes of this Order, Jersey Cycling, incorporated under Article 4 of the Loi (1862) sur les teneures en fidéicommis et l'incorporation d'associations, is the promoter.

3 Use of roads for entertainment

- (1) If the requirements as to insurance and public notice set out in Articles 7 and 8 are complied with, a specified part of a public road may be used during the specified periods for any of the following purposes
 - (a) the holding of the entertainment;
 - (b) the viewing of the entertainment;
 - (c) the making of arrangements preparatory to the holding and viewing of the entertainment.

(2) For the purposes of paragraph (1), a specified part of a public road is a part of a public road, being a public road named in column 1 of the Schedule, and being a part that runs from a location or public road specified opposite in column 2 of the Schedule to a location or public road specified opposite in column 3 of the Schedule.

4 Closure of roads so used

During the specified periods the promoter may cause a part of a public road specified in the Schedule to be closed to pedestrian and vehicular traffic for any of the purposes specified in Article 3.

5 Material required for entertainment

- (1) Between 5.00 p.m. on Monday 29th June 2015 and 10.00 p.m. on Tuesday 30th June 2015, the promoter may cause to be placed and maintained on
 - (a) the footpaths and sides of the carriageways of any part of a public road (being a part specified in the Schedule); or
 - (b) the median lines of any part of a public road (being a part so specified),

material required for the purposes of or in connection with the entertainment.

(2) However, material shall not be placed in pursuance of this Article unless adequately illuminated from half an hour after sunset to half an hour before sunrise so as to give reasonable warning to pedestrian and vehicular traffic.

6 Other arrangements for safety of public, or purposes incidental to entertainments

- (1) The arrangements set out in paragraphs (2), (3) and (4) shall also apply for the purposes of the entertainment.
- (2) Notwithstanding Article 3 of the Road Traffic (Grouville) (Jersey) Order 2002 or Schedule 1 to that Order on Tuesday 30th June 2015 in the periods between 9.00 a.m. and 1.00 p.m. and between 5.30 p.m. and 10.00 p.m. any vehicle may be driven in either direction along any of the following public roads, or parts of public roads, for the purpose of ingress to or egress from any property in that road
 - (a) Beach Road;
 - (b) Union Road;
 - (c) Gorey Village Road between the bottom of La Chèvre Rue (Daisy Hill) and Beach Road.
- (3) Notwithstanding the Road Traffic (Grouville) (Jersey) Order 2002 and Road Traffic (St. Martin) (Jersey) Order 1989, a motor vehicle shall not remain on any part of a public road, being a part specified in the Schedule, on Tuesday 30th June 2015 in the periods between 9.00 a.m. and 1.00 p.m. and between 5.30 p.m. and 9.30 p.m.

- (4) Notwithstanding the Road Traffic (Public Parking Places) (Jersey) Order 2006, a motor vehicle shall not remain in any part of the Gorey Common car park in Gorey, or the Beach Road car park in Gorey in the period between 5.30 p.m. on Monday 29th June 2015 and 9.30 p.m. on Tuesday 30th June 2015.
- (5) Nothing in paragraph (3) prevents a motor vehicle from remaining in any off-road car park during a period of closure under Article 4 of the part of the public road that provides access to the car park if the motor vehicle remains there during the entire duration of that closure.

7 Insurance cover

The requirements of this Article to which Article 3(1) refers are that the promoter must produce to the Minister evidence that there is insurance (to the satisfaction of the Minister) by Tuesday 16th June 2015 against any liability that may be incurred by –

- (a) any person organizing, supervising, or concerned in the conduct of, the entertainment;
- (b) the promoter;
- (c) any official, agent or servant of the promoter;
- (d) any person taking part in the entertainment,

in respect of damage to property, or in respect of the death of any person or bodily injury to any person, resulting from the holding or viewing of the entertainment or from any of the preparations for the entertainment.

8 Public notice of restrictions

- (1) The requirements of this Article to which Article 3(1) refers are as set out in paragraphs (2) and (3).
- (2) On 2 occasions during the 9 days immediately preceding Sunday 28th June, the promoter shall cause to be published in the Jersey Gazette notice of
 - (a) each proposed closure, under Article 4, of part of a public road;
 - (b) each arrangement that will apply under Article 6, specifying the parts of the public roads and the periods concerned.
- (3) Each notice shall be certified by the Greffier of the States as a notice that is being published in pursuance of this Order.

9 Limited access

(1) A police officer, or a person appointed by the promoter as an event marshal for the purposes of this Order, may prohibit, restrict, regulate or allow the access of persons (whether with motor vehicles or otherwise) to any part of a public road when the part is closed to traffic under Article 4, or when it is subject to arrangements under Article 6, if he or she

- considers it necessary to do so in the interests of the safety or convenience of the public.
- (2) Members of the fire service, ambulance service, coast guard or Royal National Lifeboat Institute, or police officers, may (whether with motor vehicles or otherwise) enter and use any part of a public road when it is closed to traffic under Article 4, or when it is subject to arrangements under Article 6, to the extent that it is reasonably necessary for them to do so in order to perform their duties.

10 Citation

This Order may be cited as the Island Games (Cycle Race – Grouville and St. Martin) (Jersey) Order 2015.
