# ISLAND GAMES (TRIATHLON) (JERSEY) ORDER 2015

Made
Coming into force

**THE MINISTER FOR TRANSPORT AND TECHNICAL SERVICES**, on the application of the Jersey Triathlon Club and after consultation with the Connétables of St. Helier and St. Lawrence, in pursuance of Article 2 of the Entertainments on Public Roads (Jersey) Law 1985, orders as follows –

### 1 Interpretation

In this Order –

"entertainment" means the entertainment in the form of a swimming, cycling and running race known as the Jersey Triathlon which is comprised in the event known as the Island Games 2015;

"entertainment area" means -

- (a) a specified part of a public road named in column 1 of the Schedule being the part that runs from a public road specified opposite in column 2 of the Schedule to a public road specified in column 3 of the Schedule; and
- (b) the area of the beach in St. Aubin's Bay, between the western wall of Elizabeth Marina and an imaginary line directly in line with Tyneville Lane;

"specified period" means the period between 3.45 p.m. and 6.00 p.m. on Sunday 28th June 2015 and "during the specified period" means the whole or any part of that period.

#### 2 Promoter

For the purposes of this Order, the Jersey Triathlon Club is the promoter.

#### 3 Use of roads for entertainment

If the requirements as to insurance and public notice set out in Articles 7 and 8 are complied with, any part of the entertainment area may be used during the specified period for the following purposes –

- (a) the holding of the entertainment;
- (b) the viewing of the entertainment;
- (c) the making of arrangements preparatory to the holding and viewing of the entertainment.

## 4 Prohibition, restriction and regulation of pedestrians and traffic on roads

- (1) The powers in paragraphs (2) to (8) may be exercised for the purposes of, or incidental to, the entertainment.
- (2) During the specified period the promoter may cause the following public roads or parts of public roads in the entertainment area to be closed to traffic
  - (a) the western bound carriageway of Victoria Avenue;
  - (b) La Route de la Haule;
  - (c) La Neuve Route;
  - (d) Charing Cross;
  - (e) La Route de Ste. Marie.
- (3) During the specified period the promoter may close
  - (a) La Rue du Haut to traffic proceeding west from its junction with Le Mont Cambrai;
  - (b) the spur road that leads from La Route de St. Aubin to The Esplanade to traffic proceeding east;
  - (c) the spur road at First Tower that leads from La Route de St. Aubin to Victoria Avenue to traffic proceeding west;
  - (d) Rue du Galet.
- (4) During the specified period, the promoter may close
  - (a) La Rue de la Ville Emphrie to eastbound traffic; and
  - (b) St. Peter's Valley, between Bel Royal and the junction with La Rue du Haut, to southbound traffic other than omnibuses (as defined in the Motor Traffic (Jersey) Law 1935) and large goods vehicles (as defined in the Road Traffic (Jersey) Law 1956).
- (5) During the specified period
  - (a) no vehicle shall remain on either side of La Route de St. Aubin between West Park roundabout and Bel Royal except with the permission of the promoter, a police officer or a person appointed by the promoter as an event marshal;
  - (b) no vehicle shall remain on either side of any of the following public roads, or parts of public road, except with the permission of the promoter, a police officer or a person appointed by the promoter as an event marshal –

- (i) the public lay-by lying first on the promenade, when proceeding westward from West Park,
- (ii) Victoria Avenue between Bel Royal and the Esplandade,
- (iii) La Route de la Haule as described in the entertainment area,
- (iv) La Neuve Route as described in the entertainment area,
- (v) Charing Cross as described in the entertainment area,
- (vi) the roads described in paragraph (3)(b), (c) and (d).
- (6) Notwithstanding Article 4(2) of the Road Traffic (St. Lawrence) (Jersey) Order 1990 or Part 2 of Schedule 2 to that Order, during the specified period any vehicle may be driven from La Route de la Haule into La Route de St. Aubin.
- (7) The promoter, a person appointed by the promoter as an event marshal for the purposes of the entertainment or a police officer, may, during the specified period prohibit, restrict, regulate or allow the access of persons (whether with motor vehicles or otherwise) or standing of vehicles to any part of the entertainment area if he or she considers it necessary to do so in the interests of safety or convenience of the public.
- (8) Notwithstanding anything in this Order to the contrary, members of the fire and rescue service, ambulance service, coast guard or Royal National Lifeboat Institute, or police officers, may (whether with motor vehicles or otherwise) use any public road that is in use during the specified period for the purposes of the entertainment to the extent that it is reasonably necessary for them to do so in order to perform their duties.

#### 5 Closure of beach

During the specified period for the purposes of the entertainment the promoter may restrict or prohibit access by all vehicular traffic and members of the public to the area of the beach specified in the entertainment area.

### 6 Material required for entertainment

During the specified period the promoter may cause to be placed on any public road material required for the purposes of or in connection with the entertainment.

#### 7 Insurance cover

The requirements of this Article to which Article 2 refers are that the promoter must produce to the Minister, not later than Friday 12th June 2015, evidence that there is insurance (to the satisfaction of the Minister) against any liability that may be incurred by -

- (a) any person organizing, supervising, or concerned in the conduct of, the entertainment;
- (b) the promoter;
- (c) any official, agent or servant of the promoter;



(d) any person taking part in the entertainment,

in respect of damage to property, or in respect of the death of any person or bodily injury to any person, resulting from the holding or viewing of the entertainment or from any of the preparations for the entertainment.

#### **8** Public notice of restrictions

- (1) The requirements of this Article to which Article 3 refers are as set out in paragraphs (2) and (3).
- (2) On 2 occasions during the 9 days immediately preceding Sunday 28th June 2015, the promoter must cause to be published in the Jersey Gazette a notice of the proposed closures and arrangements that will apply under Articles 3, 4 and 5, specifying the roads and periods concerned.
- (3) Each notice is to be certified by the Greffier of the States as a notice that is being published in pursuance of this Order.

#### 9 Citation

This Order may be cited as the Island Games (Triathlon) (Jersey) Order 2015.
