Introduction

A request has been received from 3D Events who are responsible for facilitating the Jersey Triathlon 2022 event for the temporary closure of 58 spaces at Les Jardins car park between 5pm Friday 15th July until 6pm Sunday 17th July 2022

Recommendation

The Minister is recommended to approve the temporary closure of 58 parking spaces of Les Jardin Car Park between 5pm Friday 15th July until 6pm Sunday 17th July 2022 to allow the Jersey Triathlon 2022 event to take place

Detail

This is the 3rd year the request has been received as the previous events have been very successful and enabled Jersey to receive widespread international publicity through various media. The event attracts competitors from several different countries and promotes the Island as a good venue for similar events and as a tourism destination. The car park has always been returned in a clean and tidy state.

The requested area will be used by the Triathlon staff and competitors for the race briefings and race pack collections.

Reason for Decision

Article 3 (c) of the Road Traffic (Public Parking Places) (Jersey) Order 2006 allows the controlling body of a parking place to close for any period and for any purpose the whole or any part of a parking place by notice displayed at the parking place.

The Road Traffic (Public Parking Places) (Jersey) Order 2006 is created in pursuance of Articles 59 and 84 of the Road Traffic (Jersey) Law 1956.

The Road Traffic (Public Parking Places) (Jersey) Order 2006 is administered by the Minister for Infrastructure.
