Introduction

The Minister for Infrastructure is asked to approve changes to the Road Traffic (St Mary) (Jersey) Order 2000 to make changes to the direction of traffic flow on La Rue a Georges and to restrict traffic to a 6 foot 6 inch width on La Rue du Couvent and the Road Traffic (St Peter) (Jersey) Order 1992 for part of La Rue du Couvent which is in St Peter in pursuance of Article 68 Road Traffic (Jersey) Law 1956 and after consultation with the Connétables of St Mary and St Peter.

Detail

The Connétable of St. Mary has requested the Department assist with problems experienced by a number of large vehicles, HGV's, using a number of by-roads in St Mary and St Lawrence as a rat run to get to Six Roads. The roads concerned are not suitable for regular use by these type of vehicles and this has resulted in damage being caused to the road surface and the banks bordering the roads as well as making the roads unsafe for pedestrians and other non-vehicular road users.

Following a site visit by traffic engineers, a proposal has been discussed with the Connétables of St Lawrence, St Mary and St Peter to seek their support. The Connétables have agreed to trial the introduction of a one way restriction on La Rue a Georges in St Mary for westbound traffic only and a 6 foot 6 inch width restriction on La Rue du Couvent which runs in both St Mary and St Peter. The route used also encompasses La Longue Rue in St Lawrence which is not suitable for this type of traffic. The decision to introduce a one-way restriction on La Rue es Georges will not require as much policing as a width restriction thus reducing the impact on the parish honorary police forces. The Minister is asked to approve these changes in pursuance of Article 68 of the Road Traffic (Jersey) Law 1956, and after consultation with the Connétables. Their impact will be monitored with any required changes made prior to the formalising of these by Amendment to the Road Traffic (St Mary) (Jersey) Order 2000 and the Road Traffic (St Peter) (Jersey) Order 1992.

Policing of these areas is undertaken by the Parish Honorary Police.

The Road Traffic (St Mary) (Jersey) Order 2000 and the Road Traffic (St Peter) (Jersey) Order 19922 are administered by the Department for Infrastructure.

Article 5 (b) Closing of roads to certain vehicles
