Introduction

- The Minister for Infrastructure is asked to approve an Amendment to the Road Traffic (St. Helier) (Jersey) Order 1996 due to area redevelopment on Bath Street. This to introduce a loading and unloading bay outside the second Premier Inn to serve the large number of commercial and domestic units in the area.
- This Amendment has been reviewed and agreed with the Parish of St. Helier, Car Park team and I&E. It will be made under the powers granted to the Minister under article 68 of the Road Traffic (Jersey) law 1956.

Recommendation

The Minister is requested to approve the introduction of a new loading and unloading bay in Bath Street, after redevelopment of the area (Appendix 1).

Policing of the new amendments of vehicles on roads for loading and unloading will be carried out by the Parish Honorary Police and Jersey Car Parks.


Schedule 10, Part 2, Parking of vehicles on footways or cycle tracks for loading and unloading
